

A Message About Your School Tax Bill

The Hempstead Town government is not funded by this bill. The two factors that determine the amount of this bill are your Nassau County assessment and the budget adopted by your local board of education.

The assessed value of residential property is determined by taking the fair market value of the property and multiplying it by a uniform percent of value (Fair Market Value X Uniform percent of Value = Assessed Value).

Appeals may be filed with the Nassau County Assessment Review Commission from January 2nd to March 1st. Visit: nassaucountyny.gov/1510/Assessment-Review-Commission for details.

For purposes of comparison, below are Nassau County's fair market valuations for your parcel:
